Our Home-Based Family Centered Casework/Therapy services and Intensive Preservation and Reunification services provide therapeutic social services and training to biological families. The goal is to prevent removal of children from their family or to prepare the family for the child's return home, when removal has been necessary. These services include case planning, conflict management, child development education, family communication, community referrals, budgeting/money management, and behavior modification. This is a strength-based service that identifies areas of need and puts a focus on short- and long-term goals. During 2015, Whittington provided 15,756 hours of service to families from 15 counties in northeast Indiana.

4b (Code: ) (Expenses \$ 14,122. including grants of \$ ) (Revenue \$ 40,042.) Community Alternatives to Psychiatric Residential Treatment Facilities (CA-PRTF) provides services for families with children and youth who have serious emotional problems. Caseworkers focus on providing extra help within the home. Services include transportation, training and support, consultive clinical and therapeutic services, respite care, funds for certain one-time purchases and habilitation. Five hundred forty-eight (548) hours of service were provided under this program during 2015.
